SCTE 2014 TECHNOLOGICAL INNOVATION AWARDS

Nominations are now being sought for the 2014 SCTE Technological Innovation Awards which will be presented at the SCTE Gala Dinner on 22 March 2014 at One George Street, London. Following the massive sell-out success of our previous dinners, this is sure to be another success.

Traditionally, the prestigious SCTE Technological Innovation Awards have only been awarded to Corporate Members of the Society but, as a result of the general interest raised, we have decided to open the awards to the whole Broadband Industry and you are, therefore, invited to nominate a product on the attached form.

Eligibility

The awards are for technological innovation in the broadband arena and may be for a product, system or concept. (Please Note: The item nominated must have been introduced into the marketplace between 1 January 2013 and 31 December 2013).

Award Categories

Awards will be given for three separate categories:

- Best broadband network transmission solution.
- Best CPE solution.
- Best digital processing solution.

In addition, the best overall submission will receive the:

- SCTE 2014 Technological Innovation of the Year Award.

Nomination Procedure

Nomination forms are to be forwarded to the SCTE office no later than the end of January 2014. Nominations can be made on the attached form or, alternatively, they can be submitted by email to office@thescte.eu. An electronic version of this form is available via the SCTE website at www.thescte.eu/index.php/about-us/awards-and-bursaries. In order to assist the judging panel in their deliberations, please limit your submission to 300 words or less; you may, however, attach product brochures, white papers etc as background information.

Judging Process

Judging will be by an independent panel of industry experts. After the closing date, judging will take place and the shortlisted candidates will be announced by the end of February 2014. The ultimate winners and runners-up will be announced at the SCTE Gala Dinner on 22 March 2014.

Prize Winners

Shortlisted candidates may use the SCTE logo and the words "Finalist, SCTE 2014 Technological Innovation of the Year Awards" in their promotional material throughout 2014. In addition, the winner's achievement will be promoted in a press campaign by the SCTE to the trade press and to its international membership.

The winners will receive a prestigious SCTE 2014 Technological Innovation of the Year Award, which will be presented at the SCTE Gala Awards Dinner on 22 March 2014 at One George Street, London. Subsidised places at the event will be made available for representatives of the winning and runner-up companies.
